#### SUMMARY

The California Association of Local Agency Formation Commissions (CALAFCO) is soliciting nominations for individual LAFCO commissioners to serve on the CALAFCO Board of Directors.

#### **Board of Directors Nominations**

The CALAFCO Board consists of 16 directors equally represented by the four regions (Northern, Southern, Central and Coastal). Each region elects four members, one from each category of representation (public, county, city, special district).

This two year election cycle for the Northern Region is for the <u>County</u> and <u>Special District</u> Board members. The deadline to submit nominations is **September 18, 2023**.

These elections are held at the CALAFCO Annual conference each year in the fall (Oct 18-20 in Monterey). Directors serve staggered two year terms.

Butte LAFCo is in the 18 county Northern Region and currently has one member on the CALAFCO Board (Connelly-*County*) whose term ends this year (2023). Commissioner Connelly has been a significant presence on the Board in advocating for the north region and rural issues in general and is currently the Chair. Commissioner Connelly remains interested in serving on the CALAFCO Board as a county representative for the Northern Region and requests Commission support. There is no restriction for a commission nominating commissioners for all available seats.

**ACTION REQUESTED:** Consider nominations for either county or special district member positions on the CALAFCO Board of Directors.
