## 4.2 Adoption of a Resolution In Support of AB361

Steve Lucas stated the Governor has rescinded his past resolution that allowed remote meetings to occur and we have to go through this step to continue to have the option to have remote Zoom meetings. The two things that changed fundamentally from our

have remote Zoom meetings. The two things that changed fundamentally from our previous instructions through the Governor's order deals with access in real time to the meeting on Zoom and the second deals with not requiring people to register on an internet site other than our own. We have always met these requirements. Nothing in this new law changes what we have been traditionally doing on Zoom. This just allows us to move forward with the option for Zoom meetings. The legislature now requires us to renew this resolution every 30 days should we choose to hold meetings on Zoom.

Marsh Burch, representative for LAFCo counsel, stated the staff report spells out all the things we need to understand to go forward.

Chair Leverenz wanted to clarify that we are going to be putting this item on our agenda every meeting going forward until we don't have to hold remote meetings anymore. He stated it makes sense to renew it at each meeting so we don't have to hold a special meeting.

Steve Lucas opened this item to the public for comment. None stated. The public hearing was closed.

Chair Leverenz made a motion to adopt Resolution No. 04 2021/22 to implement the law. The motion was seconded by Commissioner McGreehan.
