3. NOTICED PUBLIC HEARINGS

3.1 20-06 – Oroville Mosquito Abatement District (OMAD) – Dissolution and Annexation.

Shannon Costa stated the proposal involves the dissolution of the Oroville Mosquito Abatement District (OMAD) and the annexation of the same parcels to the Butte County Mosquito and Vector Control District (BCMVCD). This proposal comes to us after findings made from the 2017 Municipal Service Review and several grand jury reports regarding mosquito abatement districts in Butte County. The application came to us by resolution by the OMAD and we also received a resolution of support from the BCMVCD. The proposal was noticed and we have received no comments back from any land owners, registered voters or interested agencies. Staff is recommending adoption of the resolution which includes the conditions of approval that would require that the OMAD would satisfy the PERS contract which is their only outstanding liability and waive protest proceedings.

Steve Lucas opened this item up to the public for comments.

Jeff Carter stated this has been a long time coming. In the interim, BCMVCD has been doing an extraordinary job providing service in the OMAD service area. This is a no brainer. BCMVCD will continue to do a good job and it will be one less special district Butte County and LAFCO need to worry about.

Matt Ball, BCMVCD general manager, stated he wanted to thank Jeff Carter and OMAD with the transition period and working with them has been phenomenal. He stated he wanted to thank the LAFCO Commission and Steve for everybody's diligence. He is happy to report to his Board next week that his District will be acquiring OMAD under the objectives that they wanted, which was to take OMAD debt free. We couldn't be happier to be ready to provide public health protection to the OMAD service area.

Commissioner Connelly made a motion to adopt Resolution No. 01 2020/21 approving the dissolution and annexation. The motion was seconded by Commissioner Lambert.

Steve Lucas stated he has been in contact with Aaron, the general manager of DMAD, and Aaron is prepared to bring forth a new version of the District's website so we have something to evaluate. Depending on how the mosquito season is, we may have this on the September agenda or the October agenda at the latest.
