ADMINISTRATION:

1. The open recruitment to fill the vacant position of Deputy Executive Officer in progress. As reported earlier, we will recruit for a flexibly staffed position (DEO/Policy Analyst) which may result in a wider range of eligible candidates applying for the position. The recruitment period concludes on October 12, 2018.

CALAFCO:

1. The CALAFCO Annual Conference was held October 3-5, 2018. The Executive Officer participated on a panel discussing natural disaster preparations. The CALAFCO membership will also be conducting elections for the CALAFCO Board of Directors (North Region Public and City members).

LEGISLATION:

1. CALAFCO's signature piece of legislation, AB 2258 (Caballero), which creates a \$1.5 million grant program to fund reorganization studies (dissolutions/consolidations) evolving from MSR/SOI determinations, was vetoed by the Governor as shown below:

To the Members of the California State Assembly:

I am returning Assembly Bill 2258 without my signature.

Subject to an appropriation in the annual Budget Act, this bill requires the Strategic Growth Council to establish and administer a grant program to fund various activities performed by Local Agency Formation Commissions.

This new spending proposal should be evaluated in the annual budget process where it can be weighed together with the state's other spending priorities.
